Types of briefings safety.

Vocabulary:

Induction training – вводный инструктаж Initial briefing – первичный инструктаж Repeated briefing – повторный инструктаж Unscheduled briefing – внеплановый инструктаж Target instruction – целевой инструктаж employees – работники There are such types of briefings safety as induction training, initial briefing, repeated briefing, unscheduled briefing, target instruction.

Induction training

Induction training is performed for all **employees**

- who are accepted for permanent or temporary employment, regardless of their education, work experience and positions;

- with employees of other organizations, who arrived at the enterprise and participate directly in the production process or perform other work for the company;

- pupils and students, who came to the plant for production practice;

- in the case of trips to the enterprise;

- to all the students, pupils, students and other persons who are enrolled in secondary schools, colleges, high school institutions.

Initial briefing

Initial briefing is held before the beginning of work on the job with the employee:

- adopted at the enterprise,
- which was transferred from one shop of production to another;
- to perform new work;
- the employees in a business trips who are directly involved in the production process at the enterprise.

Is held with pupils and students:

- in the beginning of classes in each classroom,
- in the laboratory, where the educational process is associated with hazardous or harmful chemical, physical, and biological factors in circles,
- before the lessons of labour studies, physical education, in front of sports, exercises, sports implements,
- for carrying out activities outside the territory of the educational institution;
- before every training tasks associated with using different mechanisms, tools, materials, etc.;
- at the beginning of each new subject (topic, topics) training plan (program) from the General requirements security-related topics and features of the class.

Repeated briefing

Repeated briefing held by workers in the workplace in terms defined by the relevant prevailing industry regulations or the head of the enterprise taking into account the specific conditions of work, but at least: on the works of high danger - 1 times in 3 months; for the other works 1 time in 6 months.

Unscheduled briefing

Unscheduled briefing held: with workers in the workplace or in the Cabinet of a labour safety:

- at introduction in action of new or revised regulations on labour protection, as well as when making changes and additions to them;

- at change of the technological process, replacement or modernization of the equipment, instruments and tools, raw materials, materials and other factors that affect the state of labour protection;

- when violations by employees of the requirements of normative acts on labour protection, which can lead or has led to injuries, accidents, fires, etc.;

- when identifying the persons carrying out the state supervision and the control over labour protection, lack of knowledge of safety requirements in respect of work performed by the employee;

-during the break in the work of a contractor for more than 30 calendar days for works of high danger, and for the rest of the work is more than 60 days. With the pupils, students, students in classrooms, laboratories, workshops, etc. for violations of requirements of normative acts on labour protection, which can lead or has led to injuries, accidents, fires, etc.

Target instruction

Target instruction is held with employees: when performing a single work, not stipulated in the employment agreement; the liquidation of the accident, natural disaster; in the works, which issued the permit, order or other documents. It is held with pupils, students in the case of organization of mass events (excursions, trips, sporting events etc).
